RULES: 1.1 The regatta will be governed by the rules defined in “The Racing Rules of Sailing”. 1.2 The prescriptions of Sail Canada will apply. They will be posted on the Official Notice Board; Also Available: http://www.sailing.ca/files/RRS_2017_2020_Sail_Canada_Prescription_Final_EN.pdf 1.3 In the event of any differences between the Notice of Race and the Sailing Instructions – The Sailing Instructions shall apply.

ADVERTISING: 2.1 Boats may be required to display advertising chosen and supplied by the organizing authority.

ELIGIBILITY AND ENTRY: 3.1 Any fleet with five may have their own one design division. 3.2 All boats must register online at: www.yachtscore.com 3.3 Classes will be finalized based on enrollment June 24th 2021 at 16:00. 3.4 Early Bird Registration closes June 1st 2021 at 20:00. 3.5 Registration closes June 24th 2021 at 20:00. 3.6 Registration fees are Non –Refundable. 3.7 All boat owners must sign the Liability Waiver available on the event registration site: (ADDRESS FOR LIABILITY FORM) and submit to fleetcaptain@lysc.com no later than June 25th 2021 at 20:00. You may bring the waiver form and hand in at the Skippers Meeting.

FEES: 4.1 Early Bird Registration – All Classes: \$90 4.2 / Standard Registration – All Classes: \$99 * All Fees are in Canadian dollars and will have HST 13% applied to subtotal.

RACING AREA: 6.1 The racing area will be roughly located 1nm South of Lakeshore Yacht Club Entrance.

COURSE: 7.1 The course will be a multiple point to point race; at 13:30 Course Displayed by Course Cards in the window of LSYC Race Committee Boat: “Lakeshore Lady”. Approximate Duration 2 – 3 hours to Complete) – Weather Dependent.

SCORING: 8.1 All classes shall be scored with the Low Point Scoring System. 8.2 PHRF-LO will be applied to all classes that are not defined as One Design.

HAUL OUT FACILITIES 9.1 There are NO Haul out Facilities available at Lakeshore Yacht Club.

AWARDS: 10.1 Awards will be presented to the TOP 3 and LAST boat of each Division.

POST RACE RAFT PARTY : All boats are encouraged to congregate at Marie Curtis Park after finishing the Race. Location Approximately 0.3nm West of Lakeshore Yacht Club. Overnight accommodations will be subject to COVID19 restrictions at the time of the event

INSURANCE: 12.1 ALL competing boats shall be insured with valid third-party liability insurance with minimum coverage of \$2,000,000 for Canadian boats and \$350,000 for US boats.
