**Rules:** The regatta will be governed by the current Racing Rules of Sailing (RRS) and the rules of International Melges 24 Class Association. These may be changed by the Sailing Instructions.

**Eligibility:** The regatta is open to all Melges 24's as defined by their Class Rules. Competitors must meet all ownership, class membership requirements, and must have paid all event fees before becoming official competitors.

**Entries:** Eligible boats may be entered by completing registration with the organizing authority and payment of the entry fee. **Sailing Instructions:** Will be available at registration.

**Courses:** Racing will be on windward/leeward courses as specified by the Sailing Instructions. Course length will be based on sailing conditions. Racing will be on the waters of Muskegon Lake. Muskegon Yacht Club is located at 3198 Edgewater Street on the Southwest side of Muskegon Lake. The Yacht Club phone number is 231-755-1414.

**Penalty System:** The 360 degree Turn Penalty, (RRS 44.2) will apply.

**Scoring:** The Low Point scoring system, RRS Appendix A4, will apply, modified so that each boat's series score will be the total of her race scores. Six (6) or more races are scheduled, of which one (1) race shall be completed to constitute a series.

**Awards:** Appropriate awards will be presented in a timely fashion Sunday afternoon.
