1. RULES

- a. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- b. The following prescriptions of the US SAILING national authority **will not** apply:
 - 1) RRS 63.2c.
 - 2) RRS 63.4b.
- c. The following **will** apply:
 - 1) RRS Appendix T (Arbitration).
 - 2) RRS Appendix V1 (Penalty at the Time of an Incident).
 - 3) US Coast Guard safety requirements and US Sailing Near Shore safety requirements.
 - 4) One-Design classes shall digitally provide their National class rules to the OA.
 - 5) One-Design classes that intend to invoke their local class rules shall provide a digital copy of the local class rules to the OA.
 - 6) A boat, while racing, shall not operate a drone.
 - 7) For the R-C course, *disabled* boats shall be recovered at the end of the heat or regatta at the owner's expense. See RRS Appendix E.

2. ADVERTISING

- a. The Regatta is sponsored by Skyway Yacht Works of Chicago, IL.
- b. All competitor or boat advertising shall be in compliance with World Sailing Regulation 20.
- c. Racing yachts are requested to not display advertising for competing companies.

3. ELIGIBILITY AND ENTRY

- a. The Colors Regatta has four different courses. Competitors are allowed to register for one and only one of these courses in addition to the R-C course. The courses are:
 - 1) Offshore (generally comprised of larger keelboats)
 - 2) Inshore (generally comprised of smaller boats)
 - 3) Distance (can be comprised of any boat that meets the relevant safety requirements, including GLSS)
 - 4) Radio Controlled (R-C) – DragonForce 65 only

NOTICE OF RACE

- b. The regatta is open to all boats of the below class(es), by course specified in NOR 3c:
- 1) One-design classes with a minimum of 3 entries. Entrants must meet and follow all class requirements, unless modified by the SIs. If there are less than the minimum number of required entries for a class, the OA will assign those boats into appropriate handicap classes. The OA's decision shall be final.
 - 2) Lake Michigan Performance Handicap Racing Fleet (PHRF) and ORR classes with a current, valid Rating Certificate and a minimum of 5 entries.
 - 3) Short-handed (GLSS, doublehanded) with a current, valid Rating Certificate as required by GLSS and a minimum of 3 entries.
 - 4) Cruising Class – with a current, valid Rating Certificate (PHRF), and a minimum of 3 entries shall comply with the following:
 - a) Boats shall be limited to carrying two roller furling headsails. A whisker pole may be used to wing out the headsail.
 - b) Boats may not use a spinnaker pole to tack a spinnaker. Boats shall be limited to carrying two asymmetrical spinnakers. The Tack Point of Spinnaker (“TPS”) shall be attached at the centerline of the boat at the stem or on a bowsprit. In no event shall TPS exceed 125% of “J”.
 - c) Power-driven winches and mechanical and electro-mechanical steering devices are permitted. This changes RRS 52.
 - 5) 30 and Under – keelboats, with a minimum of 3 entries, that:
 - a) Are inshore boats that measure 30 feet or less LOA.
 - b) Have an LMPHRF rating greater than 114.
- c. Boats will be divided into classes.

- d. Notwithstanding any of the above; any group of three (3) or more boats, desiring to race as a separate class, may petition the OA for acceptance as a class. Petitions shall be made no later May 24, 2020.
- e. Eligible boats may enter by completing the online registration at www.yachtscoring.com together with the required fee listed in the appropriate column of the table located in NOR 5 before May 1, 2020.
- f. Eligible boats may enter as Late Entries by completing the online registration at www.yachtscoring.com together with the required fee listed in the appropriate column of the table located in NOR 5 in the between May 1 and May 30, 2020.
- g. Entered, registered boats complying with NOR 3e or 3f may withdraw from the Colors regatta by emailing their intent to regattachair@colyc.org prior to 23:00:00 CT on May 30th, 2020.

4. CLASSIFICATION

World Sailing Regulation 22 applies if national class rules state.

5. FEES

- a. Fees will be refunded in full if the entry is withdrawn prior to 23:00:00 CT on May 30th, 2020.
- b. Required fees are as follows:

- b. Maximum number of races for each course:

- c. For the Inshore and Offshore courses, the intent of the Race Committee is to complete as many races as practical each day, which shall not exceed the number of races scheduled.
- d. For the Distance course, one race is scheduled for Saturday. Sunday is reserved in the event inclement weather forces cancellation of racing Saturday.
- e. At the option of the classes on the Inshore course, racing may be shortened to one day only. This must be decided and communicated to the OA no later than Monday, June 1st at 18:00 CT. If this option is exercised, awards for the Inshore course will be held during the post-race party Saturday.

7. MEASUREMENT

- a. Measurement and weigh-ins will not be conducted by the OA.
- b. A boat shall comply with RRS 78.1 (Compliance with Class Rules).

8. SAILING INSTRUCTIONS (SIs)

- a. SIs will be available by May 25th, 2020 at www.yachtscoring.com.
- b. There will be separate SIs for each course.

9. VENUE AND COURSES

- a. The racing areas and courses to be sailed Michigan shall be on the waters of Lake as follows:

- b. Location coordinates for all courses will be in the corresponding SIs.

10. PENALTY SYSTEM

- a. RRS Appendix T is in effect.
b. RRS Appendix V1 is in effect.

11. SCORING

- a. The scoring system is as follows:
- 1) For the Inshore, Offshore, and R-C courses, each boat's series score shall, subject to rule 90.3(b), be the total of her race scores. No score will be excluded. This changes RRS Appendix A2.1.
 - 2) For the Distance course, each boat's score shall be from the one completed race.
 - 3) PHRF classes on the Inshore and Offshore course shall be scored Time-on-Time (TOT).
 - 4) PHRF classes on the Distance course shall be scored Time-on-Distance (TOD).
 - 5) ORR classes shall be scored based on course configuration.
- b. For each class, one race completed will constitute a Regatta.

12. SUPPORT BOATS

- a. While classes are racing, support boats shall stay at least 100 yards from all racing yachts and all race committee vessels.

13. BERTHING

- a. All boats must adhere to COLYC docking rules while moored at COLYC. Docking rules are available by emailing the Columbia Dockmaster at Chuck@colyc.org.
- b. There will be a limited amount of complimentary dockage available at COLYC from 1500 hours Thursday, June 4 through Sunday, June 7.
- c. This dockage will be in a side tie configuration with other boats rafted alongside at least 2-3 deep.
- d. Non-resident boats that are participating in the NOOD regatta will be offered a 50% discount on dockage fees through June 16, based on availability.
- e. Berthing at Belmont Harbor (for boats on the Inshore course) to be arranged with Chicago Yacht Club by the owners.

14. RADIO COMMUNICATION

- a. Except in an emergency, a boat that is racing shall not make voice or data transmissions, and shall not receive voice or data communication that are not available to all boats.
- b. Commercial pay services, i.e. XM Radio, SailFlow, PredictWind, are considered to be available to all boats.

15. PRIZES

- a. For classes with four or more boats entered, there will be prizes for the top three finishers in each class.
- b. For classes with three or fewer boats entered, only the first-place finisher for that class will be awarded a prize.

16. DISCLAIMER OF LIABILITY

- a. Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race.

NOTICE OF RACE

- b. The organizing authority, race committee, protest committee, designated Club representatives, and volunteers directly assisting to any events listed in NOR 6a will not accept any liability for material damage, personal injury, or death sustained in conjunction with, prior to, during, or after the regatta.

17. INSURANCE

- a. Each participating boat in the Offshore or Distance courses shall be insured with valid third-party liability insurance with a minimum coverage of \$500,000 per event or the equivalent.
- b. Each participating boat in the Inshore course shall be insured with valid third-party liability insurance with a minimum coverage of \$300,000 per event or the equivalent.
- c. There is no insurance requirement for boats participating in the R-C course. Racing in the R-C course shall be at your own risk for damage and injury. Restitution for damage, replacement, and salvage shall be by arrangement of parties involved in the incident causing damage and / or sinking.
