

BACARDI INVITATIONAL WINTER SERIES REGATTA - EVENT #2

NOTICE OF RACE

The organizing authority is Twelve USA, Inc. Biscayne Bay Yacht Club will provide the race committee and serve as the host club. Additional berthing available at Shake-A-Leg Miami.

1. RULES

- **1.1** The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- **1.2** Only the following US Sailing prescriptions shall apply: RRS 40, 61.4, 60.3, 67, 70.5(a), 76, Appendices R and V1.
- **1.3** Except for the rules in RRS PARTS 2 and 3, the jury may impose alternate penalties for breaking a rule, in accordance with RRS 64.1.
- **1.4** If there is a conflict between languages, the English text will prevail.
- **1.5** If there is a conflict between the notice of race, the sailing instructions, and any other rules of the regatta, the sailing instructions will take precedence. This changes RRS 63.7.
- **1.6** All boats shall carry a functioning VHF radio for monitoring the race committee and emergencies.

2. ADVERTISING

2.1 Boats may be required to exclusively display the event sponsor's advertising in accordance with World Sailing (*WS*) Regulation 20, materials to be supplied by the organizing authority at check-in. *WS* Regulation 20.9.2 will apply.

3. ELIGIBILITY AND ENTRY

- **3.1** Boats must be eligible for entry in accordance with *WS*, J70, and Melges 24 class rules.
- 3.2 Entry will be online: https://bacardiinvitational.com/winterseries2/
- **3.3** The deadline for entry is December 22nd, 2020. Entry is not complete unless accompanied by the complete entry fee. Late entries after December 22nd will be subject to an additional late fee.
- **3.4** All contestants, person in charge and crew, are required to sign the regatta waiver form online to complete a boat's entry.

4. CLASSIFICATION

4.1 To enter a Corinthian Division all of the competitors on a boat must be eligible for 'Group 1' as defined in *WS* Regulation 22.2.1, as well as meeting the requirements of their class for Corinthian status.

7. MEASUREMENT

- **7.1** The 'person in charge' (RRS 46) shall promptly present a valid measurement certificate upon request from the jury.
- **7.2** Crew weight limits will be in compliance with class rules, however, no crew weigh-in is scheduled.
- **7.3** Boats may be subject to equipment inspection, measurement, and crew weigh-in at any time if ordered by the jury following a valid protest.

8. COURSES

- **8.1** The race course is on Biscayne Bay approximately 3 nm south of Dinner Key Channel marker FIG2.5s5M'1'.
- **8.2** Courses will be windward/leeward with gates and offsets, as diagrammed on the sailing instruction APPENDIX COURSES.

9. SAILING INSTRUCTIONS AND AMENDMENTS

9.1 Amendments to the notice of race and sailing instructions will be posted on the event website at: www.bacardiinvitational.com/winterseries2/

10. PENALTY SYSTEM

- **10.1** As changed in this notice of race, rules 1.2 and 1.3.
- **10.2** The time for jury hearings on the last day of the regatta may be shortened.

11. SCORING

- **11.1** The Melges 24 Class is scheduled for eight races with a minimum of three completed races to constitute a regatta. When four or more races have been completed, a boat's score will be the total of her race scores excluding her worst score.
- **11.2** The J70 Class is scheduled for six races with a minimum of two completed races to constitute a regatta. When three or more races have been completed, a boat's score will be the total of her race scores excluding her worst score.
- **11.3** There will be overall prizes for the Series. To qualify the fleet score from Event #3 will be added to the lowest total score of either Event #2 or #3. The boats with the lowest total scores win and the others will be ranked accordingly.

12. LAUNCHING/BERTHING/HAUL OUT/TRAILER STORAGE

- **12.1** Launching/berthing/haul out and trailer storage for the J/70 and MELGES 24 Classes will be at BBYC and Shake-A-Leg Miami.
- **12.2** Melges 24s will be launched by 0900, January 22, 2021. J70s will be launched by 0900, January 23,2021.

13. HAUL-OUT RESTRICTIONS

13.1 Boats will not be hauled during the regatta, except with written permission from the regatta chairman or jury.

14. RADIO COMMUNICATIONS

14.1 Except in an emergency, a boat that is racing shall not make or receive voice or data transmissions that are not available to all boats.

15. SUPPORT PERSONS AND BOATS

15.1 Support Persons and their vessels are to be governed by the RRS.

16. COMPETITOR IDENTIFICATION

- **16.1** A 2021 Bacardi Invitational Winter Series wristband is required for entrance into hospitality areas. Wristbands will be distributed during check in.
- **16.2** Each competitor must present a valid photo ID together with an event voucher to receive a wristband. If no valid photo ID is presented, the individual will receive an 'under 21' wristband and will be precluded from consuming alcoholic beverages.
- **16.3** Guest wristbands will be available for purchase at check in and at the hospitality tent entrance each evening.

17. INSURANCE

17.1 Each participating boat shall be insured with current third party liability insurance with a minimum coverage of not less than \$100,000/300,000. A copy of the coverage page will be submitted at the first check in of a boat.

18. DISCLAIMER OF LIABILITY

18.1 In addition to RRS 4, DECISION TO RACE (RRS2017-2020), or RRS 3, DECISION TO RACE (RRS2021-2024), the safety of a boat and her entire management shall be the responsibility of the owner(s), and an owner's representative. Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including disease and death, sustained as a result of participation in these events. By participating in these events, each competitor agrees to release the race organizers from any and all liability associated with participation in this event to the fullest extent permitted by law.

- 18.2 Based on any public health consideration, competitors agree to follow Centers for Disease Control and Prevention (CDC), State of Florida and County of Miami-Dade guidelines and Biscayne Bay Yacht Club policies regarding coronavirus, COVID-19, that are in effect at the time of each regatta.
- **18.3** Before participation at any event, every owner, competitor, coach and/or support personnel shall sign a Waiver of Liability as posted on Yachtscoring.
- **18.4** By participating in these events, each competitor agrees to release the regatta organizers from any and all liability associated with participation in this event to the fullest extent permitted by law.

19. MEDIA RIGHTS

19.1 Competitors give absolute right and permission for video footage and photographs of themselves or their boat to be published in any media for press, editorial, or advertising purposes.
