



# Anchorage Cup 2020

## Notice of Race

September 12, 2020

### 1. RULES

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2. The rules of PHRF as administered by LMPHRF shall apply.
- 1.3. The Notice of Race and any amendments thereto.
- 1.4. The Sailing Instructions and any amendments thereto.
- 1.5. Jib and Main shall take exception to the use of spinnakers, asymmetrical spinnakers, cruising spinnakers, staysails or the like. None are allowed. Spinnaker poles, whisker poles and the like are allowed if attached to the mast and do not exceed the J dimension of the boat.

### 2. ELIBIGILITY AND ENTRY

- 2.1. The regatta is open to mono hull boats that:
  - 2.1.1. Are at least 20 feet in length, are fitted with an auxiliary engine, are seaworthy and meet the minimum requirements of the U.S. Coast Guard.
  - 2.1.2. Have current insurance certificate with \$300,000 liability coverage.
  - 2.1.3. Have a VHF marine radio with channels 16 and 69.
  - 2.1.4. Have submitted an entry form and paid the entry fee by the entry deadline.
  - 2.1.5. A start will also be provided for a multihull division if a minimum of 3 entries are submitted.
- 2.2. Registration may only be made by completing the online forms and submitting payment at: [www.yachtscoring.com](http://www.yachtscoring.com) by **Wednesday, September 9, 2020**.
- 2.3. Late entries will be accepted under the following conditions:
  - 2.3.1. Entries received after September 9, 2020, but before midnight September 10, 2020 may be accepted at the discretion of the Race Committee and shall be assessed a late fee of \$50 in addition to the entry fee.
  - 2.3.2. Acceptance of any late entries will be at the sole discretion of the Race Committee.
- 2.4. A completed entry is defined as all forms having been completed online and all appropriate entry forms having been received by the host club prior to the event.

### 3. FEES

The entry fee shall be paid by credit card online at the time of registration. Required fees are as follows:

US Sailing Member	\$95
Non-US Sailing Member	\$100

### 4. SCHEDULE

- 4.1. Check-In: Boats may check in Friday evening, September 11, 2020 between 6PM and 9PM. Saturday September 12, check in is between 7:30AM and 9AM at the Grand River Sailing Clubhouse.
- 4.2. Skippers Meeting will be held at 9:30AM, September 12 in the grandstands.
- 4.3. Number of races: There will be two concurrent races. Both the Spinnaker fleet and the Jib and Main fleet will be rated and scored under LMPHRF.
- 4.4. The first warning signal is scheduled for 11:30AM.

5. SAILING INSTRUCTIONS

Sailing Instructions will be published on Yacht Scoring.

6. MEASUREMENTS

If a valid measurement certificate is not provided, the Race Committee will have sole discretion to assign a rating.

7. THE COURSE

The course shall be from Grand Haven to Holland with a gate (and possible alternate finish) at Port Sheldon.

8. SCORING

A yacht's corrected time will be computed by subtracting her handicapped time from her elapsed time. Corrected times will then be ranked from low to high.

9. RADIO COMMUNICATION

Radio Communication will be on channel 69.

10. PRIZES

10.1. Prizes will be distributed by division for first, second and third place in each division.

10.2. Awards will also be presented for first, second and third place for the JAM and Spinnaker fleet finishers.

10.3. Each of the Jam and Spinnaker fleet winners shall also have their boat name engraved on the Anchorage Cup trophy.

11. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

12. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 per incident or the equivalent.

**SPECIAL DOCKING NOTE:** Do not try to make a reservation using the DNR website. If you plan on docking *in a slip* at the Grand Haven Municipal Marina on Thursday and/or Friday night, you **must reserve a slip** through the Anchorage Cup at [AnchorageCupChair@yahoo.com](mailto:AnchorageCupChair@yahoo.com). Tell them that you are a participant in the Anchorage Cup and you want to reserve one of the slips that have been blocked out. They may tell you that all slips are taken for Friday, (the race committee has blocked out 22 slips for the race). There is NO rafting allowed off the end of the slips this year. You must register with the marina office if you have a slip. If you have any problems reserving a slip, please contact Diane DeVries [devriesdianek@gmail.com](mailto:devriesdianek@gmail.com).

Slips that are not reserved will be un-blocked, effective July 20, 2020. Do not count on showing up in Grand Haven and getting a slip without a reservation. Please note that the Race Committee has no control over the Grand Haven Municipal Marina in regard to slip availability, pricing or other rules & policies governing the use of the Grand Haven Municipal Marina. The Anchorage Cup does not receive any revenue or other compensation from the DNR for slip rental.
