**18 DISCLAIMER OF LIABILITY**

- 18.1 In addition to RRS 3, DECISION TO RACE, the safety of a boat and her entire management shall be the responsibility of the owner(s) and the owner's representative. Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. The regatta organizers (organizing authority, race committee, protest committee, technical committee, host club, sponsors, or any other participating organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event.
- 18.2 By participating in this event, each competitor agrees to release the regatta organizers from any and all liability associated with participation in this event to the fullest extent permitted by law.
- 18.3 Before participation at this event, every owner, competitor, coach and/or support personnel shall sign a Waiver of Liability attached here, as posted on the event website, and on the YachtScoring ONB.

- 3 I have taken all necessary steps to ensure that myself, the crew and the entered boat are adequately prepared for all possible contingencies, including appropriate safety equipment as may be required by law or that a prudent seaman would consider advisable.
