

# Monroe Wednesday Skyline Series Chicago Yacht Club (OA) Monroe Harbor, Chicago, IL May 12 - September 29, 2021

## **NOTICE OF SERIES**

[DP] Rules for which the penalties are at the discretion of the protest committee.

[NP] Rules that are not grounds for a protest or request for redress by a boat. This changes RRS 60.1(a).

#### 1 RULES

- 1.1 The races will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The LMPHRF Rating System Time-on-Time (ToT) for buoy races will apply to all boats, except for one-design sections.
- 1.3 The following US Sailing prescription will not apply: 63.1.
- 1.4 **[DP]** Boats shall not fly drones while racing or in the racing area.
- 1.5 All applicable governmental regulations regarding health, safety and infectious disease control shall be strictly followed by all competitors.
- 1.6 Competitors using any Chicago Yacht Club facilities, including docks, must follow <u>House and Ground Rules In</u> *Effect Due to Covid-19*.
- 1.7 Violations of Section 1.5 and 1.6 of this Notice of Series shall not be protestable by a competitor but may be protested by the Race Committee or Organizing Authority. *This changes RRS 60.1.*
- 1.8 Crews must consist of 2 or more persons. *This changes J/70 Class rule C.3.1(a), T-10 Class rule 5.1 and Etchells Class Rule C.2.1 (a).*
- 1.9 LMPHRF Certificate crew limitations do not apply.

#### 2 SAILING INSTRUCTIONS

- 2.1 The sailing instructions will be available no later than Monday, May 10 at 1800.
- 2.2 The sailing instructions include sailing instructions from Columbia Chicago Beer Can Series <a href="https://www.yachtscoring.com/emenu.cfm?eID=14459">https://www.yachtscoring.com/emenu.cfm?eID=14459</a> as amended by Chicago Yacht Club at <a href="https://www.yachtscoring.com/emenu.cfm?eID=14495">https://www.yachtscoring.com/emenu.cfm?eID=14459</a>.
- 2.3 In addition to this Notice of Series, The Columbia Chicago Beer Can Series NOS also applies. In the event of a conflict, this NOS will prevail.

### 3 COMMUNICATION

- 3.1 The online official notice board is located at <a href="https://www.yachtscoring.com/emenu.cfm?eID=14459">https://www.yachtscoring.com/emenu.cfm?eID=14459</a> and <a href="https://www.yachtscoring.com/emenu.cfm?eID=14495">https://www.yachtscoring.com/emenu.cfm?eID=14459</a> .
- 3.2 All boats shall carry a VHF radio capable of communicating on US Marine Frequencies.
- 3.3 **[NP]** On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The channel will be stated in the SIs. Failure to receive courtesy broadcasts shall not be grounds for a request for redress. *This changes RRS 62.1(a).*
- 3.4 **[DP]** While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 ELIGIBILITY AND ENTRY

4.1 The races are open to sailboats owned by Members in good standing of Chicago Yacht Club and meet the



## following requirements:

- a. Boat is 20 feet or longer.
- b. Boat has either a valid LMPHRF certificate or has acquired a Beer Can PHRF rating.
- 4.2 All boats must complete Yacht Scoring registration at <u>both</u> the Columbia's Yacht Scoring Page <a href="https://www.yachtscoring.com/emenu.cfm?eID=14459">https://www.yachtscoring.com/emenu.cfm?eID=14459</a> and the Chicago YC Yacht Scoring page <a href="https://www.yachtscoring.com/emenu.cfm?eID=14495">https://www.yachtscoring.com/emenu.cfm?eID=14495</a>.
- 4.3 **[NP]** While valid LMPHRF certificates are encouraged for boats not sailing one-design, the ColYC Regatta Manager will assign ratings to boats without certificates.
- 4.4 To be considered an entry in an event or the series, a boat shall complete all registration requirements and pay all fees.

#### 5 FEES

- 5.1 The entry fee for the entire series will be \$100 (paid to Columbia) and \$20 paid to Chicago YC.
- 5.2 Entry fees will not be refunded for any reason.

## 7 SCHEDULE

7.1 Races are on Wednesdays as follows: 5/12 thru 7/7 & 7/28 thru 9/8 hosted by ColYC and 9/15 thru 9/29 hosted by CYC.

#### 8 VENUE

- 8.1 ColYC-hosted races will be held on the Chicago Beer Can Racecourse per the ColYC NOR available at <a href="https://www.yachtscoring.com/emenu.cfm?eID=14459">https://www.yachtscoring.com/emenu.cfm?eID=14459</a>.
- 8.2 CYC-hosted races will be held in the open waters of Lake Michigan east of Monroe Harbor.

## 9 COURSES

- 9.1 Courses for races hosted by ColYC will be held on the Chicago Beer Can Racecourse, a circle of 8 permanent marks located southwest of the Four-Mile Crib. All races for ColYC hosted races will start from SA7, the center mark of the racing circle.
- 9.2 Courses for races hosted by CYC will be distance races around fixed government marks.

#### 10 PENALTY SYSTEMS

10.1 RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

#### 11 SCORING

- 11.1 Each individual race shall be scored using the low-point scoring system of RRS Appendix A. All races in the series count with 3 allowed throw outs. *This changes RRS A2.1.*
- 11.2 For all events, boats participating in the Monroe Wednesday Skyline Series will be scored separately from boats participating from other clubs.
- 11.3 When a boat competes in a section other than what they have registered for, that week's racing results will not count towards their season standings.
- 11.4 The CASRA 100 Boats on a Beer Can Race on Wednesday 8/11 will count towards season standings in the Monroe Wednesday Skyline Series. The Feeder race on Tuesday 8/10 will not count toward the series.
- 11.5 Rule A5.3 applies.

#### 12 PRIZES

- 12.1 Weekly prizes will be given at the discretion of the organizing authority to maximize fun and camaraderie which may not be prizes for true winners but rather for new winners and not likely for repeat winners.
- 12.2 The Organizing Authority will have the discretion to not award weekly prizes for sections in which less than 2 boats participated in that week's races.



- 12.3 When a boat competes in a section other than what they have registered for, they will not be eligible for weekly prizes.
- 12.4 Prizes will be awarded to the top finishers in each section and the fleet for the overall season based on the number of participants.
- 12.5 The overall fleet winner for the series will have their name engraved on the Skyline Bell in the Mac bar.

## 13 DISCLAIMER OF LIABILITY

Competitors participate in any of these Races entirely at their own risk. See RRS 3, Decision to Race. The Organizing Authorities will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 14 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per incident or the equivalent.

#### 15 PHOTOGRAPHY AND VIDEO RIGHTS

Competitors give absolute right and permission for any photographs or video footage taken of themselves or their competing boat to be published in any media whatsoever for editorial, commercial purposes, or to be used in press information.
