Bayview Yacht Club ("Bayview") is the Organizing Authority ("OA") of this event.

## NOTICE OF RACE

## 1 RULES

1.1 The Race will be governed by the rules as defined in The Racing Rules of Sailing ("RRS"). The US Sailing prescription to RRS 63.2 will not apply.
1.2 Appendix T will apply.
1.3 Boats must carry all safety equipment required U.S. by Coast Guard regulations.
1.4 If there is a conflict between this Notice of Race ("NoR") and the Sailing Instructions, the Sailing Instructions take precedence. This changes RRS 63.7.

## 2 ADVERTISING

Boats may be required to display advertising chosen and supplied by the OA. Advertising shall be restricted to ISAF Advertising Code 20.2.2 and 20.2.3.

## 3 ELIGIBILITY AND ENTRY

3.1 The Race is open to all boats at least 20 feet LOA.
3.2 Boats must sail with at least two crewmembers.
3.3 Boats wishing to enter the Race shall register online at the event website at www.yachtscoring.com.

The deadline for entries is $\mathbf{1 2 0 0}$ hours on Friday, June 4, 2021.
3.4 For a one-design class to have a start, it must have at least six entries by the deadline for entries. If there are not enough boats in a class to meet that minimum, the OA will assign the boats to a PHRF class.

4 SCHEDULE
The Race will be sailed on Saturday, June 5, 2021. The warning signal is scheduled for 1330 hours.
5 MEASUREMENT AND RATINGS
All boats must have a valid 2021 DRYA PHRF certificate and race in full compliance with that certificate. However, the OA will assign a PHRF rating to boats without a 2021 DRYA PHRF certificate.

## SAILING INSTRUCTIONS

Sailing Instructions will be available at the event website at www.yachtscoring.com not later than Thursday, June 3, 2021.


## 7 VENUE AND COURSE

7.1 The racing area will be the waters of Lake St. Clair and the Detroit River.
7.2 The Canadian border currently is closed by the Canadian government due to COVID-19. If the border remains closed on June 5, 2021, boats shall not cross the border or sail in Canadian waters at any time.
7.3 The start will be in Lake St. Clair off Crescent Sail Yacht Club. Boats will sail from the start to G"17" (left to starboard) and proceed to the finish line in the Detroit River in front of Bayview Yacht Club.

## 8 SCORING

8.1 Boats racing in handicap classes will be scored using their PHRF ratings to determine their time-on-time (TOT) corrected times.
8.2 Boats racing in one-design classes shall be scored in their order of finish.
8.3 Boats that do not complete registration before 1200 hours on Friday, June 4, 2021, will not be scored. See NoR, 3.3.

## 9 DOCKING AND SOCIAL EVENTS

Docking privileges will be extended to entered boats at Bayview for after-race events. All skippers and crews are invited to attend the Bayview Dock Party following the race.

## 10 PRIZES

Prizes will be awarded at Bayview after the Race to the top three competitors in each class.

## 11 DISCLAIMER OF LIABILITY

Competitors participate in the Race entirely at their own risk. See RRS 3, Decision to Race. The OA, sponsors, race committee and the officers, governors and staff of Bayview will not accept any responsibility for material damage or personal injury or death sustained in conjunction with or prior to, during or after the Race.

## 12 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of $\$ 300,000$ per incident or the equivalent.
