

# NOTICE OF RACE 2022 T-TEN NORTH AMERICAN CHAMPIONSHIP REGATTA AUGUST 10<sup>TH</sup> – AUGUST 14<sup>TH</sup>, 2022 DETROIT FLEET BAYVIEW YACHT CLUB DETROIT, MICHIGAN

**Regatta Location:** Bayview Yacht Club (BYC), 100 Clairpointe St., Detroit, MI 48215 (313-822-1853)

Registration will be held at BYC.

**Organizing Authority (OA):** Detroit Fleet in cooperation with the T-Ten Class and BYC.

### 1. RULES

- 1.1. The T-Ten North American Championship (NAC) will be governed by the *rules* as defined in the current Racing Rules of Sailing (RRS) and the North American Championship Regatta Regulations, except as any of these are altered by the Notice of Race (NOR) or the Sailing Instructions (SI).
- 1.2. The US Sailing Prescriptions shall apply with the exception of the prescriptions to RRS 63.1 and 63.2 which will not apply.
- 1.3. RRS V1, Penalty at the Time of an Incident, will apply.

## 2. ADVERTISING

- 2.1. Advertising shall conform to World Sailing Regulation 20.
- 2.2. If provided by the OA, removable bow stickers of contrasting color shall be attached to both sides of the boat's hull at all times while racing. The stickers are to be attached with the top approximately 8'-10" below the deck level and with the leading edge approximately 10"-12" aft of the bow. Bow stickers will be provided in the Regatta Skipper's Package at registration. Breach of this rule shall not be subject to protest or a request for redress by a boat. This changes rule 60.1.

# 3. ELIGIBILITY AND ENTRY

- 3.1. The NAC is open to contestants that comply with Article 6 of the T-Ten NAC Regatta Regulations.
- 3.2. Eligible boats shall enter online at <a href="www.yachtscoring.com">www.yachtscoring.com</a> by July 18, 2022.
- 3.3. Late entries will be accepted until August 1, 2022.
- 3.4. No entries will be accepted after August 1, 2022 unless approved by the Championship Committee.
- 3.5. In addition to online entry and payment, registration/check-in requires completion of the following documents no later than scheduled registration:
  - 3.5.1. Boat measurement declaration
  - 3.5.2. Signed sail declaration
  - 3.5.3. Crew weigh-in form
  - 3.5.4. Qualification affidavit
  - 3.5.5. Required safety equipment declaration
  - 3.5.6. Owner/Helmsman waiver (complete on yachtscoring.com)

- 3.5.7. Crew waiver (complete on yachtscoring.com)
- 3.5.8. Insurance policy (see NOR paragraph 18.1)
- 3.6. Registration will be conducted at BYC.
- 3.7. Scanned forms and digital signatures are acceptable. Documents can be sent via email to hanson@totalfoundationsllc.com.
- 3.8. If registration is not complete the Regatta Skipper's Package with bow numbers will be withheld. Registration must be complete before 1930 August 10, 2022.

## 4. FEES

- 4.1. The entry fee will be \$375.
- 4.2. The late entry fee will be \$500.
- 4.3. An administrative fee of \$50 will apply to all cancellations and refunds on or before July 18, 2022. No refunds will be granted after July 18, 2022.
- 4.4. Social package tickets will be sold at an additional cost.

#### 5. INSTRUCTIONS

5.1. The SI will be posted on the event page at <a href="www.yachtscoring.com">www.yachtscoring.com</a>.

## 6. RACING AREA

- 6.1. The racing area will be on Lake St. Clair and will be detailed in the SI.
- 6.2. The courses will be windward/leeward.

## 7. SCHEDULE

7.1. Three races are scheduled each day for the first three days and two races are scheduled for the final day, although at the discretion of the Race Committee the number of races each day can be increased or decreased depending upon the conditions and/or whether a sufficient number of races have been completed to constitute a series.

0730-0800 Supplemental crew weigh-in

1400 No warning signal after this time

## 8. **MEASUREMENTS**

- 8.1. Each yacht shall have a valid measurement certificate.
- 8.2. Yachts should be measured by their local fleets prior to the event. Boats requiring on-site measurement should contact the T10 Class Measurer prior to July 25, 2022 to make arrangements.
- 8.3. The OA may direct a boat to be inspected and measured at any time before, during or after the regatta.
- 8.4. Sail measurements will be available at BYC on August 10, 2022.

## 9. SCORING

- 9.1. A boat's series score will be the total of all of her race scores. This changes RRS A2.1.
- 9.2. Four completed races are required to constitute a series.

#### 10. AWARDS

- 10.1. Prizes will be awarded in accordance with the T-Ten NAC Regatta Regulations.
- 10.2. Daily prizes will be awarded.
- 10.3. Prizes will be awarded to the top three places overall.
- 10.4. Other special prizes may be awarded.

# 11. SUPPORT BOATS

11.1. There shall be no contact or communication by coach or support boats with entered boats from the time of departure from the dock until the finish of the last race of the day.

#### 12. LAUNCHING

- 12.1. Boats shall be in the water by 1900 on August 10, 2022.
- 12.2. Launching and haul-out will be provided to traveling entries at BYC at no additional cost.

## 13. BERTHING

13.1. All competitor boats must moor at BYC August 10-14, 2022.

# 14. HAUL-OUT RESTRICTIONS

14.1. A boat shall not be hauled out during the regatta except with prior written permission by the Protest Committee.

## 15. RADIO COMMUNICATIONS

15.1. Except in an emergency, a boat shall neither make radio transmissions nor receive radio communications not available to all boats while racing. This restriction also applies to mobile phones and other electronic devices. Reception of publicly available "smart phone" application information is permitted.

# 16. PHOTOGRAPHER AND TV RIGHTS

16.1. Competitors give absolute right and permission for any photographs or video footage taken of themselves or their competing boat to be published in any media whatsoever for editorial, commercial purposes, or to be used in press information.

# 17. DISCLAIMER OF LIABILITY

17.1. Competitors participate in the regatta entirely at their own risk. See RRS 3, Decision to Race. The OA will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

# 18. INSURANCE

18.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of US \$300,000 per incident or the equivalent.
