**NOTICE OF RACE, WITH AMENDMENT #1**

See highlighted changes to 1(e) and 3.

**1. Rules –**

1.1 – The regatta will be governed by the rules as defined in The Racing Rules of Sailing.

1.2 – The USSailing Prescription to Rule 63.4 will not apply. The USSailing Prescriptions are available at [www.ussailing.org/](http://www.ussailing.org/).

1.3 The Racing Rules will be changed as follows.

a) Race Signal AP – when displayed ashore, ‘one minute’ is replaced by ‘thirty minutes’.

b) 44.1– the ‘Two-Turns Penalty’ is replaced by the ‘One-Turn Penalty’, except a situation where RRS Appendix V1 will apply.

c) App A2 - A boat’s series score will be the total of her race scores (no throwouts).

d) App A4.2 – A boat that does not finish (DNF) a race or retires after finishing (RAF) shall be scored one more point than the last boat to finish in that race.

e) RRS Appendix T will apply, except the penalty in RRS T1(b) is changed to 20% if taken before an arbitration meeting

**2. Eligibility, Entry & Fees**

2.1 The regatta is open to all boats that conform to the rules of the International Melges 24 Class.

2.2 Eligible boats may enter at [www.yachtscoring.com](http://www.yachtscoring.com) and paying the required fees. Access to online registration will be available during the designated registration periods

2.3 The required fee for the regatta is \$50.00 payable online at [yachtscoring.com](http://yachtscoring.com) or at registration. Yachts will not be scored until the entry fee is paid

**3. Schedule**

**4. Sailing Instructions** — will be available at registration and online at [Yachtsscoring.com](http://Yachtsscoring.com)

**5. Venue** – will be West Grand Traverse Bay south of Power Island.

**6. The Courses** – will be 4 Leg Windward/Leewards.

**7. Penalty System** – RRS 44.1 is changed so that the ‘Two-Turns Penalty’ is replaced by the ‘One-Turn Penalty’.

#### **8. Scoring**

8.1 As many races as practical will be sailed. One (1) race is required to be completed to constitute a series.

8.2 A boat’s series score will be the total of her race scores (no throwouts). This changes RRS App A2.

8.3 A boat that does not finish (DNF) a race or retires after finishing (RAF) shall be scored one more point than the last boat to finish in that race. This changes RRS App A4.2

**9. Boat Launching** – Boats will be dry sailed from ramps at either GTYC or Elmwood Township Marina.

**10. Radio Communication** – Communication for the racing will utilize VHF radios on a channel to be announced . Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

**11. Prizes** – will be awarded to crews placing 1st through 3rd in the regatta. Additional prizes may be awarded.

**12. Disclaimer of Liability** – Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor’s participation in this event to the fullest extent permitted by law.

**13. Image & Video Rights** — Competitors give absolute right and permission for video footage or photographs of themselves or their boat to be published in any media for press, editorial or advertising purposes.

**14. Insurance** – Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 (USD) per incident or the equivalent.

Further, participants UNDERSTAND AND AGREE that this release includes any Claims based on the actions, or omissions, of the GTYC, its employees, agents, and volunteers, whether a COVID-19 infection occurs before, during, or after participation in any GTYC event.
