

Notice of Race Mudhead Benefit Cup for Always Home • Friday-Saturday, July 15-16, 2022 (Racing on Saturday only)

- I. RULES
 - 1.1. The Series is governed by the rules as defined in The Racing Rules of Sailing.
 - I.2. Changes to rules will be noted in the Sailing Instructions.
- 2. SAILING INSTRUCTIONS
 - 2.1. The Sailing Instructions will be available online after July 1st.
- 3. COMMUNICATION
 - 3.1. The official Notice Board is online through www.mudhead.org/RACING.
 - 3.2. The Race Committee (RC) will use VHF Channel 01A for courtesy broadcasts.
- 4. ELIGIBILITY AND ENTRY
 - 4.1. The Mudhead Benefit Cup is open to PHRF, ORC, One Design & NEMA classes.
 - 4.2. Classes shall be assigned by the Race Committee.
 - 4.3. All entrants shall hold adequate insurance.
 - 4.4. Registration is online at www.mudhead.org/RACING beginning April 1, 2022.
 - 4.5. Registration deadline is 1800 EDT, Friday, July 15.
- 5. FEES
 - 5.1. The entry fee is ZERO per boat. This is a charity event, please consider a donation online when registering. All proceeds go to Always Home.
 - 5.2. Tickets for the MegaParty are \$30 per person and may be purchased online.
- 6. SCHEDULE
 - 6.1. Skipper's meeting and Racer's Jam is July 15 at 1800 at Mystic Shipyard.
 - 6.2. First Warning for all classes is scheduled for 1055 on Saturday, July 16.
- 7. VENUE
 - 7.1. The Racing Area is in Fishers Island sound.
 - 7.2. Starting Circles will be designated based on number of classes entered.
- 8. COURSES
 - 8.1. The courses sailed will be Windward-Leeward or Around the Buoys, as selected by the RC.
- 9. SCORING
 - 9.1. Some classes may sail multiple races. One completed race constitutes a series. There are no exclusions. RRS A2.1 is modified.
- 10. PRIZES
- 10.1. Class, Overall and Fundraising Trophies will be awarded at the MegaParty under the tent at Mystic Shipyard beginning at 1700 on Saturday, July 16.
