# NOTICE OF RACE

### 1. RULES

- 1.1 The Organizing Authority (OA) will be the Coconut Grove Sailing Club, sanctioned by the Snipe Class International Racing Association (SCIRA).
- 1.2 The event will be governed by the *rules* as defined in *The Racing Rules of Sailing* (RRS), the SCIRA Rules for Conducting an International Championship, the Deed of Gift, this Notice of Race (NoR) and the Sailing Instructions.
- 1.3 The Rules for Conducting International Championship (RoC) may be found at:

- 1.4 The Deed of Gift (DG) may be found at:  
<https://www.snipe.org/wp-content/uploads/2022/11/Vieri-Lasinio-Di-Castelfero-Trophy.pdf>
- 1.5 US Sailing Prescriptions to RRS 60.3, 61.4, 67, 76.1 and Appendix R shall apply. Please see Addendum 1.
- 1.6 Per RRS 91(b), an International Jury will be appointed in accordance with Appendix N. The decision of the Jury will be final in accordance with RRS 70.5.
- 1.7 RRS Appendix P will apply.
- 1.8 RRS 35 and RRS 63.1 will be changed to provide that boats not finishing within 30 minutes after the first boat to finish will be scored "Did not Finish" without a hearing.
- 1.9 RRS 62.2 will be changed to shorten the time limit for requesting redress and the requesting that a hearing be re-opened on the last day, to no later than 30 minutes after the decision was posted.
- 1.10 RRS 30.4 will not be used.
- 1.11 RRS 32.1 and RRS 64.3 will be changed to compel the Race Committee/Jury to abandon a race as required by SCIRA RoC 18.

1.12 If there is a conflict between languages the English text will take precedence.

## 2. ADVERTISING

2.1 Advertising will be permitted in accordance with World Sailing Regulation 20.

2.2 Boats may be required to display advertising chosen and supplied by the OA.

## 3. ELIGIBILITY AND ENTRY

3.1 The event is subject to the following Vieri Lasinio Di Castilvero Trophy Deed of Gift Restrictions:

3.1.1 Contestants must be under 22 years old (not having their 22nd birthday during 2024).

3.1.2 All skippers must be citizens or bonafide residents for at least one year, of the country they represent. Each must present credentials signed by their National Secretary attesting that they are the entrant. Boats, skippers and crews shall be in good standing and current in the year with SCIRA.

3.1.3 Ten skippers from any country, preferably the National Champion of the current year.

3.1.4 One additional skipper from the host country, providing that it does not have among its other representatives the Junior World, Junior European or Junior Western Hemisphere & Orient Champion.

3.1.5 In addition to the entrants above:

- The Current Junior World Champion if they are otherwise eligible.
- The Junior European Champion if they are otherwise eligible.
- First Junior from Western Hemisphere & Orient Championship if they are otherwise eligible.

3.1.6 Must have 5 countries and 2 continents to conduct the championship.

3.1.7 Bow numbers are assigned at registration and it shall be each competitor's sole responsibility to properly affix them in conformance with the instructions and to properly maintain them.

3.1.8 Eligible competitors shall enter by completing an entry form on the official website for registrations <https://jrworlds.snipechampionships.org/> and [https://yachtscoring.com/event\\_registration\\_email.cfm?eid=16009](https://yachtscoring.com/event_registration_email.cfm?eid=16009). Entries must be received no later than **December 11**, 2023. No late Entries shall be accepted.

## 4. FEES

4.1 Entry fee is USD \$395.00 and the payment must be completed by **December 11**, 2023. The entry fee includes all social events and ceremonies and annual dues for each skipper and crew.

4.2 No entry fee will be refunded after **December 4**, 2023 and 50% of entry fee will be refunded in case of canceled entries to the registration if it is done before this date.

## 5. SCHEDULE

5.1 The event schedule may be changed with the approval of SCIRA and will be specified in the Sailing Instructions, however, the days allocated for racing will not be changed.

5.2 Last possible initial warning signal on the last day will be 1430.

5.3 Three (3) races will constitute the regatta.

## 6. MEASUREMENT

6.1 Measurement will take place at Coconut Grove Sailing Club.

6.2 All boats shall produce a valid measurement certificate and are subject to measurement at any time at the reasonable discretion of the Class or Race Committee.

6.3 All boats are required to have a current Class decal properly displayed.

## 7. SAILING INSTRUCTIONS

7.1 The Sailing Instructions will be available at the race office from January 2, 2024, and published on the website of the championship:

## 8. VENUE

8.1 **Addendum 2** shows the Club Area.

8.2 The intended race-course area will be on Biscayne Bay in an area approximately 1 to 3 miles SSE of Brennan Channel Marker "1" (FIG. 5 sec. 8ft). See **Addendum 3**.

## 9. COURSES

9.1 The courses to be sailed are the Class approved courses for the official regattas as published on the current SCIRA web site and will be published in the Sailing Instructions.

## 10. SCORING

10.1 The low Point Scoring System, RRS Appendix A, will apply.

10.2 RRS 64.2 A9 is modified so that any breakdown points or RDG Points equal the average earned to the nearest tenth of a point (round .05 and greater upward) of the competitor's points in the series except the drop race (if any) and the race in question.

10.3 If six (6) races are completed, the worst race shall be excluded.

## 11. SUPPORT BOATS VESSELS

11.1 Support boats vessels shall register, within the limits specified in NOR 5.1 above, to the OA, that will assign an identification to be visibly displayed on the boat vessel throughout the event. The entry fee for coaches is \$150.00 to be paid at the Race Office at the moment of registration or through the website

- 11.2 All coaches, parents, guardians and ‘designated adults’ are support persons (See RRS definition Support Person and NoR 14).
- 11.3 Each support vessel shall have a working VHF radio and monitor the radio, an anchor suitable for anchoring and a basic first aid kit.

## **12. INSURANCE**

- 12.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 per incident or the equivalent.

## **13. RADIO COMMUNICATION**

- 13.1 Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats.
- 13.2 This restriction also applies to mobile telephones.

## **14. DISCLAIMER OF LIABILITY**

- 14.1 Competitors participate in the event entirely at their own risk. See RRS 3, Decision to Race. The OA will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

## **15. RIGHTS TO USE NAME AND LIKENESS**

- 15.1 By participating in this event, competitors automatically grant to the SCIRA, the OA and the event sponsors, the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recording, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

## **16. PRIZES**

- 16.1 The Vieri De Lasinio Di Castelfero Perpetual Trophy will be awarded to the winning skipper in accordance with the DG conditions.
- 16.2 Trophies will be awarded to the top 5 boats and top women’s team.

## **ADDENDUM 1 - US SAILING PRESCRIPTIONS THAT WILL APPLY**

**Rule 60.3** After rule 60.3 add:

US Sailing prescribes that rule 60.3(b) is changed to:

(b) request redress for a boat or call a hearing to consider redress:

**Rule 61** Add at the end of rule 61:

### ***61.4 Fees for Protests and Requests for Redress***

***US Sailing prescribes that no fees shall be charged for protests or requests for redress.***

**Rule 67** After rule 67 add:

***US Sailing prescribes that:***

- (a) A boat that retires from a race or accepts a penalty does not, by that action alone, admit liability for damages.***
- (b) A protest committee shall find facts and make decisions only in compliance with the rules. No protest committee or US Sailing appeal authority shall adjudicate any claim for damages. Such a claim is subject to the jurisdiction of the courts.***
- (c) A basic purpose of the rules is to prevent contact between boats. By participating in an event governed by the rules, a boat agrees that responsibility for damages arising from any breach of the rules shall be based on fault as determined by application of the rules, and that she shall not be governed by the legal doctrine of 'assumption of risk' for monetary damages resulting from contact with other boats.***

**Rule 76.1** After rule 76.1 add:

***US Sailing prescribes that an organizing authority or race committee shall not reject or cancel the entry of a boat or exclude a competitor eligible under the notice of race and sailing instructions for an arbitrary or capricious reason or for reason of race, color, religion, national origin, gender, sexual orientation, or age.***
