

Florida State J/24 Championship & District 10 Championship July 29 & 30, 2023 Coconut Grove, FL. NOTICE OF RACE

1. Rules

The Regatta is organized under the authority of J/24 Biscayne Bay Fleet 10 and hosted by J/24 Fleet 10 with venue provided by SHAKE-A-LEG MIAMI (SALM). This regatta will be governed by the rules as defined in The Racing Rules of Sailing.

2. Eligibility

The regatta is open to all J/24 sailboats as defined by the IJCA and possesses a valid measurement certificate. Competitors must meet all ownership and class membership requirements and complete all aspects of the registration process.

3. Entry and Fees

A completed entry form must be received no later than 1000 July 29, 2023. Regatta Entry Fee: \$150.00 Registration fee includes all racing, and any entertainment TBD at this time Launching/Hauling SALM, included w/ Entry.

4. Schedule of Events

Saturday July 29, 2023 1130 Competitors' Meeting at SALM Breezeway 1200 Harbor Horn 1300 First Warning Signal Following Racing Social Activities

Sunday July 30, 2023 1000 Harbor Horn 1100 First Warning Signal No warning signal after 1400 Following Racing Awards and Social Activities

5. Inspection

All boats are subject to random inspection or measurement by the Race Committee at any time during the Regatta for Rules Compliance. No boat will be allowed to compete without a fully completed and compliant Part D Class Measurement and Inventory of Required and optional Equipment forms. All participants will be subject to verification of declared crew weight per Class Rule 5.1 and encapsulated corrector weights per Class Rule 3.7.2.

6. Sailing Instructions

Sailing Instructions will be available at the completion of registration. Changes to the Sailing Instructions will be posted no later than 15 minutes after the Competitors' Meeting to be effective on Saturday, July 29, or 0800 on Sunday, July 30 to be effective on that date. On-the-water changes may be made to the Sailing Instructions in accordance with Rule 89.2[c] after Flag L is displayed.

7. Regatta Venue

SALM, 2620 S. Bayshore Dr, Miami, FL. Competitors will be permitted to use all facilities including hoists, docks, parking and trailer storage – Offsite auto/trailer parking to be arranged if necessary.

8. Racing Area

The racing area will be that part of Biscayne Bay in the vicinity of Quick Flash Mark Red "2", $25 \circ 43.266 \text{ N} 080 \circ 12.467 \text{ W}$, approximately $\frac{1}{2}$ mile north of the east end of the Dinner Key Channel.

9. Courses

The courses will be Windward/Leeward courses with drop marks per the Sailing Instructions.

10. Scoring

The Low Point scoring system RRS Appendix A will be modified such that a boat's worst score will be excluded after completion of six races. Seven (7) races are scheduled of which one (1) shall constitute a Regatta. This modifies Rule A2.

11. Alternative Penalties

The scoring penalty rule 44.3 will apply when a boat may have broken a Rule in Part 2 of the RRS.

12. Prizes

Prizes will be awarded for the top three places.
