## NOTICE OF RACE

## 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Boats shall observe the current Minimum Equipment Recommendations of YRA of LIS, Race Category C.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Sections A, B and D of Appendix T will apply as changed:
  - (a) Appendix T1 of Section A is deleted and replaced with:

The first two sentences of rule 44.1 are changed to: 'A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 in an incident or rule 31 while racing. However, when she may have broken one or more rules of Part 2 in an incident while in the zone around a mark other than a starting mark, her penalty shall be a Two-Turns Penalty.'

(b) Add to Appendix T5.4 of section D:

The arbitrator will not be a member of the jury that hears the protest but will be permitted to observe testimony presented and offer testimony. This changes rule 63.3(a).

- 1.5 To be eligible for the YRA Youth Challenge Cup:
  - a) a yacht must participate in at least three qualifying events.
  - b) at least one third of the crew shall be between 14 and 24 years old in a given calendar year with the breakdown as stated in Addendum A.
  - c) participating yachts are requested to fly code flag "Juliet" on its backstay and add the initials "YC" after the yacht's name on the entry form
  - d) owners must declare the total number of crew and number of crew between 14 and 24 years old on the entry or by e-mail to the organizing authority prior to the start of the event
  - e) details on scoring and a list of all qualifying events can be found in the YRALIS Racing Program or on the YRA website.

## 2 ELIGIBILITY AND ENTRIES

- 2.1 The regatta is open to IRC, PHRF, and One Design Racer/Cruisers and Non-Spinnaker Boats. At the discretion of the race committee, some divisions may be divided into separate classes.
- 2.2 Eligible boats may enter by registering online at Yacht Scoring: <a href="http://www.yachtscoring.com">http://www.yachtscoring.com</a> and submitted no later than 1700, Wednesday, July 13, 2016.
- 2.3 The Entry Fee is \$100.00
- 2.4 For those classes not sailing One-Design, entries shall be accompanied by a valid PHRF or IRC rating certificate. PHRF certificates from other areas will be adjusted to conform to the YRA of LIS. IRC certificates do not need to be endorsed. PHRF handicaps for boats not rated by the YRA of LIS will be assigned by the Regatta Committee based upon best available information.
- 2.5 For boats racing PHRF or IRC, any weight credit/limit listed on the PHRF or IRC certificate will be waived. There will not be a minimum or maximum weight limit in effect for any PHRF or IRC boat.

## 3 SCHEDULE, COURSES AND RACING AREA

- 3.1 The racing area will be in the waters off Larchmont Harbor.
- 3.2 The first warning will be at 1355 each day.

Date Format
Sat July 16 Windward-leeward with multiple races at the discretion of the race committee
Sun July 17 Pursuit Race with a single race

Sat July 23 Windward-leeward with multiple races at the discretion of the race committee

Sun July 24 Execution Rocks Race with a single race

Courses will be as described in the sailing instructions.

## 4 SAILING INSTRUCTIONS

- 4.1 Sailing instructions will be available at least one week before the regatta on the internet at: <a href="http://www.yachtscoring.com">www.larchmontyc.org</a> and <a href="http://www.yachtscoring.com">http://www.yachtscoring.com</a> or at the Larchmont Yacht Club front desk or the Hospitality Desk on the day of the event.
- 4.2 Scratch sheets will be available at the front desk after 1800 Friday, July 15, or the Hospitality Desk during the event, from a race committee boat prior to the first warning signal of the day, and online at YachtScoring.com.

#### 5 SCORING

- 5.1 One completed race constitutes a series.
- 5.2 If fewer than five races are completed, a boat's series score will be the total of her race scores. If five or more races are completed a boat's series score will be the total of her race scores excluding her worst score subject to rule 90.3 (b).
- 5.3 For PHRF, time allowances will be computed using Time on Distance. For IRC the boats rating allowance will be applied as a factor of the elapsed time.

## 6 PRIZES

- 6.1 Daily prizes will be awarded to the top boat in each division after racing each day.
- 6.2 Series prizes for First, Second and Third places in each division will be awarded on Sunday, July 24 after the completion of racing on the front lawn of the Larchmont Yacht Club.
- 6.3 Certain perpetual trophies will be awarded at the discretion of the race committee, including the best combined score for Saturday windward-leeward racing, best combined score from Sunday government mark racing, fastest elapsed time in the Execution Rocks Race, and fastest corrected time in the Execution Rocks Race.
- 6.4 The team that sets a new elapsed time course record in the Execution Rocks Race will receive a case of Mt. Gay Rum. The current elapsed time record is 43 minutes 57 seconds, set by yacht ELVIS on 19 July 2015.
- 6.5 This regatta is a qualifying event for the YRA Youth Challenge Cup, the Sally Finkbeiner Trophy, the Gitano, Sappho, Competitors, Kings Point and Allegra Knapp Mertz awards.

- 7.1 Guest moorings will be available on a first come basis at no charge. Reservations are required. Please contact Marine Facilities at 914-468-7742 or boatyard@larchmontyc.org

#### 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing* and the North American WoodenBoat Regatta Series 2016 Rules.
- 1.2 Boats shall observe the current Minimum Equipment Recommendations of YRA of LIS, Race Category C. Paragraphs 2.1, 2.2, 2.3, 2.4, 2.5, 2.6, 2.7 & 2.8, as appropriate, do not apply to boats not designed and equipped with pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Sections A, B and D of Appendix T will apply as changed:

Appendix T1 of Section A is deleted and replaced with:

The first two sentences of rule 44.1 are changed to: 'A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 in an incident or rule 31 while *racing*. However, when she may have broken one or more rules of Part 2 in an incident while in the *zone* around a *mark* other than a starting *mark*, her penalty shall be a Two-Turns Penalty.'

## 2 ENTRIES

- 2.1 Eligible boats may enter by submitting an entry online at <a href="www.yachtscoring.com">www.yachtscoring.com</a> Entries must be submitted no later than 1700, Wednesday, July 13, 2016
- 2.2 The entry fee is \$85.00, payable on line.
- 2.3 At the discretion of the race committee separate divisions may be assigned. Divisions may be divided into classes.
- 2.4 CRF ratings shall be submitted with the entry as sec/mile.

The arbitrator will not be a member of the jury that hears the protest but will be permitted to observe testimony presented and offer testimony. This changes rule 63.3(a).

## 2 CLASSES

- 2.1 The regatta is open to the following one-design classes: Viper 640, Etchells, J/70, IOD, Shields, S-Boat, Ideal 18, K6 or any other one-design class that qualifies. To qualify as a class for this regatta, three valid entries must be received for that class prior to 1800, Wednesday, July 13.
- 2.2 A class may elect to race on one weekend instead of the two that are scheduled. On days when a class elects not to race, boats in that class will not get a start, nor will they be scored, provided that the race committee has been previously informed of such class decision.

## 3 ENTRIES

## 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Non-inflatable, Coast Guard-approved personal flotation must be worn by skipper and crew at all times while on the water, except briefly while changing or adjusting clothing or personal equipment. This changes rule 40 and the preamble to the Part 4 rules.
- 1.3 Sections A, B and D of Appendix T will apply as changed:
  - (a) Appendix T1 of Section A is deleted and replaced with:

The first two sentences of rule 44.1 are changed to: 'A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 in an incident or rule 31 while *racing*. However, when she may have broken one or more rules of Part 2 in an incident while in the *zone* around a *mark* other than a starting *mark*, her penalty shall be a Two-Turns Penalty.'

(b) Add to Appendix T5.4 of section D:

The arbitrator will not be a member of the jury that hears the protest but will be permitted to observe testimony presented and offer testimony. This changes rule 63.3(a).

- 1.4 Class Rule 4.2 is amended to permit the use of non-builder sails; however boats must declare their use at registration. A boat or equipment may be inspected at any time for compliance with class rules.
- 1.5 Boats may be required to display bow numbers provided by the organizing authority.

- 2.1 The regatta is open to all boats of the Vanguard 15 one-design class.
