The International Rolex Regatta threeday weekend in the U.S. Virgin Islands is a high point for many yachtsmen and yachtswomen from around the world. Known as the "Crown Jewel of the Caribbean" it represents an opportunity to shake off the winter dust in preparation for a hard summer's racing. For others, it is a chance to mix sailing and racing with a family vacation in one of the Caribbean's favorite locations. Whatever the reason, once experienced, the International Rolex Regatta becomes an annual mark on the calendar. The warm clear waters, beautiful surroundings and excellent competition draws sailors back year after year.

1 MANAGEMENT

The St Thomas Yacht Club (STYC) International Rolex Regatta Committee is the Organizing Authority for this event.

2 RULES

2.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing 2009-2012.

2.2 Caribbean Sailing Association (CSA) Rating Rule. Crew limitations for CSA classes will be in accordance with the CSA Rating Rule. CSA rating information can be found at www.caribbean-sailing.com.

2.3 IRC Rule Part 1,2 and 3. Crew limitations for IRC Classes will be the number of crew listed on the IRC Certificate, plus one. IRC Rating information can be

found at www.rorcrating.com. 2.4 Minimum safety requirements found in Appendix A of this Notice of Race.

2.5 Multihull Advisory Committee, for multihull classes.

2.6 Portsmouth yardstick, for Beach Cats. 2.7 The minimum number of crew aboard each boat shall be four, except for Beach Cats which shall have a minimum of two crew aboard.

3 ADVERTISING

3.1 The 37th International Rolex Regatta 2010 is designated Catagory C, Advertising is allowed in accordance with ISAF Regulation 20. Competitors are required to respect the brand exclusivity of the Official Sponsor of this event. Rolex's participation enhances the event for all competitors.

3.2 All boats shall display the event bow stickers on their bow and Rolex flags as prescribed in the Sailing Instructions, for the duration of the Regatta.

4 ELIGIBILITY AND ENTRY

4.1 International Rolex Regatta 2010 is extending an invitation to CSA, IRC, Multihulls, Beach Cats and One-Design classes with a minimum length of 24' with current rating certificates. One-design classes and groups of boats wishing to race level will have a separate class or will be scored as a separate sub-class within their class at the discretion of the STYC Rolex Regatta Committee based on the number of entries and the event classes that are established.

4.2 You are encouraged to enter on-line at www.rolexcupregatta.com.

4.4 The entry fee for the regatta is as follows: \$400.00 (US) for all boats except Beach Cats and \$225.00 (US) for Beach Cats for all entries received before March 12, 2010; **\$500.00** (US) for all late entries.



4.5 The completed entry form, and appropriate fees must be received at STYC no later than 17.00 Tuesday, March 24, 2010.

4.6 Registration will take place at St. Thomas Yacht Club from 10.00 - 15.00 Thursday, March 25, 2010.

4.7 As part of the registration process, each boat shall complete a crew list form and each individual participating crewmember will be required to sign a disclaimer of liability and media release.

4.8 Requests for crew substitutions shall be made in writing to the Chief Judge or O.A.

6 SAILING INSTRUCTIONS

Sailing Instructions will be provided in each Registration Package distributed at registration. Sailing instructions will be available on the regatta web site: www.rolexcupregatta.com

THE COURSES 7

The Regatta Committee intends to conduct a varied and challenging schedule of races including both windward-leeward and distance courses in the waters surrounding the archipelago of the U.S. Virgin Islands.

PENALTY SYSTEMS 8

8.1 Rule 44.2 is changed such that the penalty shall be one turn including one tack and one gybe that in all other respects complies with rule 44.2.

8.2 Rule 44.3, Scoring Penalty, may be available to boats that may have broken a rule of Part 2 or failed to sail the proper course.

PROTESTS 9

An International Jury will be appointed in accordance with rule 90(b) and Appendix N. Decisions of the International Jury will be final in accordance with rule 70.4.

10 SCORING

10.1 A maximum of 15 races are scheduled for the One-design classes sailing w/l course.

10.2 A maximum of 12 races are scheduled for all other classes.

10.3 A boat's series score will be the sum of her race scores without a discard. **10.4** One completed race shall constitute a series.

11 RADIO COMMUNICATION

All competing boats shall carry a VHF radio capable of receiving communications from the Bace Committee on channels 71 and 72.

12 PRIZES

Prizes will be awarded following the racing on Sunday, March 28, 2010. Prizes will be given to first place, second place and third place in each class. A Rolex timepiece will be awarded to the top CSA spinnaker racer as determined by the Race Committee and to the winners of IRC 1, IRC 2, IC-24 and other classes at the discression of the O.A.

13 DISCLAIMER OF LIABILITY

Competitors agree to be bound by the International Sailing Federation Racing Rules of Sailing (RRS) 2009/2012, by the Sailing Instructions and the Notice of Race. Competitors agree to take any and all responsibility for the nautical qualities of their yacht, the rigging, the crew's ability and the safety equipment. Competitors also agree to take any and all responsibility for damages caused to third persons or their belongings, to themselves or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility the St. Thomas Yacht



Club and all persons involved in the organization under whatever qualification and to accept full responsibility for the behavior and dress of the yacht's crew, representatives and guests. Competitors are to be acquainted with ISAF RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". In any case, competitors agree that the St. Thomas Yacht Club, the sponsors and their agents, in particular ROLEX S.A., have no responsibility for loss of life or injury to members or others, or for the loss of, or damage to any vessel or property. As part of the registration process, each individual participating crewmember will be required to sign a declaration accepting this disclaimer of liability.

14 PHOTOGRAPHIC AND MEDIA RIGHTS

Competitors will be asked to grant ROLEX S.A. and the Organizing Authority the unrestricted right and permission to use the name and the image for any text, photograph or video footage of either themselves or the yacht they are sailing during the event to be published or broadcast in any media whatsoever (including but not limited to Press and TV advertisements or Internet), for either editorial or advertising purposes or to be used in press information; in this respect, competitors' names and any biographical material of themselves may also be used or reproduced in any way known. As part of the registration process, each individual participating crewmember will be required to sign a declaration accepting this waiver of rights.

APPENDIX A MIMIMUM SAFETY REQUIREMENTS FOR THE 37TH ANNUAL INTERNATIONAL ROLEX REGATTA

In the event of a conflict between these requirements and applicable class rules, the class rules will apply.

SAFETY REQUIREMENTS FOR CSA, IRC AND MULTIHULLS CLASSES

1.1 Softwood plugs, or other suitable materials, tapered to fit into all thru hull fittings.

1.2 Lifelines and bow and stern pulpits, or lifelines secured in such a way as to form a stern pulpit, of not less than 18" in height, except lifelines may be split at the bow to facilitate sheeting. Lifelines shall be taut with not more than seven feet between supports, taut being defined as no apparent sag between the supports. Lifelines shall be attached securely and in such a way that no part of the system is elastic in nature.

1.3 Fire extinguisher, charged and in date, accessible from the deck.

1.4 Two buckets, of not less than two gallons capacity, fitted with lanyards of suitable strength and length.

1.5 One anchor with chain of suitable size for boat's length and displacement with a suitable rope of at least 150 feet in length. No part of the anchor shall overhang the ends of the boat while racing.

1.6 A First Aid kit suitable for rendering First Aid treatment in minor emergencies.

1.7 Charts covering the area to be raced.1.8 Lifejackets constructed to an accepted standard, for each person on board, with a whistle attached. Lifejackets shall be of a suitable size for the intended wearer and readily accessible.

1.9 One life ring capable of supporting the largest member of the crew in the water and positioned above deck such that it is immediately available for use in an emergency.

1.10 Heaving line at least 50 feet in length, capable of floating, positioned above deck

such that it is immediately available for use in an emergency.

1.11 Four red hand flares and two orange smoke flares.

1.12 VHF radio capable of transmitting and receiving on emergency and race committee channels.

1.13 A compass suitable for navigation.**1.14** A shutoff valve, in working order,

shall be fitted to each fuel tank.

1.15 Hatches, companionways and ports shall be capable of being made watertight while racing.

1.16 Cockpits to be self-bailing and fitted with adequate drains.

1.17 Sufficient water shall be carried on board so that at the finish of a race there remains at least one pint per person.

2 SAFETY REQUIREMENTS FOR BEACH CATS

2.1 Life jacket to be worn by each crew member.

2.2 Independent righting line. (Not the jib sheet.)

2.3 Distress flag, 2' x 2', International orange.

2.4 One quart drinking water for each crew member. (This water must be present at the start of the race.)

2.5 50 foot towing line.

2.6 USCG approved emergency strobe light.

2.7 Three (3) USCG approved emergency aerial signal flares.

2.8 A VHF radio is required.

3 SAFETY REQUIREMENTS FOR IC-24 CLASS

The safety requirements for the IC-24 Class are as specified in the IC-24 Class Rules.

HISTORY AND SHOPPING IN ST. THOMAS

The prominence of St. Thomas as one of the Caribbean's most renowned shopping meccas is, for many, perhaps the most alluring attraction. Unrivaled by any other Caribbean destination, shopping in St. Thomas – combined with fine dining and top quality accommodation – offers truly exceptional value.

Stretched along the waterfront, restored 17th and 18th century warehouses – that once held molasses, rum, spices and other trade goods awaiting export – now house a variety of unique shops containing modernday treasures. Duty free bargains and exotic treasures can be found in Charlotte Amalie, Yacht Haven and Havensight and Port of Sale Malls.

Charlotte Amalie Harbor is the perfect place for visitors to begin their walking journey through St. Thomas history. Recently refurbished Fort Christian, built in 1672, is the oldest standing structure in the Virgin Islands. This brick fortress was constructed to protect the town's harbor from raiding European armadas, which sailed the Caribbean centuries ago. Having served as St. Thomas' first Government House, a church and community government center, Fort Christian today is home to the Virgin Islands Museum.

To continue your journey, stroll along the island's winding roads, away from the heart of Charlotte Amalie, to Government House. Visitors interested in getting a glimpse of local political life may tour the first two floors of the building. Continue on, climbing up the 99 Steps (actually 103), which take you to the summit of Government Hill. This vantage point offers a truly breathtaking view of the harbor.

Near the top of the 99 Steps loom the remnants of the medieval-style Fort Skytsborg. Better known as Blackbeard's Castle, it is one of the many structures erected as part of the Danish colonial government's attempt to protect the island. While there is no evidence that pirates inhabited the tower, Fort Skytsborg continues to hold special intrigue for legend believers. Formerly used as a residence and an observatory, Blackbeard's Castle is on the National Register of Historic Places and today doubles as both a popular restaurant and hotel.

Complete your tour with a stroll through St. Thomas Market Square or Emancipation Garden – appropriately named in the commemoration of governor Peter von Scholten's emancipation of the slaves on July 3, 1848. Whether soaking up the sun on one of our many beautiful beaches, shopping along the downtown waterfront, or touring historical sites spanning nearly three centuries, St. Thomas visitors will find plenty to fill their days.

ST. CROIX: RICH IN HERITAGE

The historical treasures of St. Croix harken back to a time when the island was a prosperous commercial port and pirates looted its coastline. Colorful shops and fine restaurants, housed in old colonial structures, line St. Croix's wide streets. The distinctly 18th Century European architecture reflects a period when seven flags - Spanish, Dutch, British, French, Knights of Malta, Danish and American flew at different times over the island. Away from the towns of Christiansted and Frederiksted, visitors to St. Croix can discover reminders of the days when sugar cultivation was the island's main industry. Blessed with captivating natural beauty, extraordinary historic sites, lively cultural

extraordinary historic sites, lively cultural traditions and the Virgin Islands' only casino, St. Croix offers a mix of attractions that has visitors wanting to return.

ST. JOHN: UNSPOILED NATURE

St. John, the smallest of the most wellknown U.S. Virgin Islands, is known for its unspoiled beaches and National Park. Established in the 1950's with land donated by American financier Laurance Rockefeller, the park now protects about two-thirds of the 19-square mile island, including more than 5,600 acres of offshore marine habitats. The white sandy beaches are shaded, in contrast, by green seagrape trees and coconut palms. The crystal clear waters are home to a dazzling array of coral reefs and tropical fish.

At Cruz Bay, the island's main town, visitors can take in an eclectic mix of boutiques, art galleries, bars and fine restaurants, while still enjoying the island's characteristically slow pace of life.
