1. ORGANIZING AUTHORITY

2. RULES

2.1. The regatta will be governed by rules as defined in the 2017-2020 Racing Rules of Sailing.

3. ELIGIBILITY AND ENTRY

- 3.1. The regatta is open to all sailboats 20ft or longer; that are equipped with a GPS and VHF radio capable of broadcasting and receiving on VHF channel 69, meet US Coast Guard safety requirements, as well as US Sailing nearshore requirements.
- 3.2. All boats must register by Friday July 28, 2017 online at www.yachtscoring.com. The entry fee is \$95.
- 3.3. Assignment of 3 Crib Fiasco handicaps is offered as an accommodation and such handicaps are not subject to competitor review or protest.
- 3.4. Boats that do not have a Lake Michigan Performance Handicap Racing Fleet (LMPHRF) certificate or will be racing in a configuration different from that declared for the LMPHRF certificate SHALL apply for a rating by submitting a rating application to the Columbia Yacht Club Office no later than July 22, 2017 at 1700.
- 3.5. This will be a Pursuit Race, competitors starting time will be providing on www.yachtscoring.com no later than July 30, 2017 at 9am.

5. SAILING INSTRUCTIONS

5.1. The initial sailing instructions will be available after 1700 on July 26 at www.yachtscoring.com. The Sailing Instructions will be updated periodically to reflect the newer entries into the starting sequence.

6. SCORING

6.1. Boats will be scored in order of finishing place, as the starting times account for handicaps.

7. DOCKING

7.1. Docking will be made available to all competitors on the day of the race to all competitors free of charge at the Columbia yacht Club Dock. Hail the Dock on channel 78 when approaching.

8. PRIZES

8.1. Prizes will be awarded to first through fifth during the regatta party.
