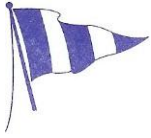

#### **NOTICE OF REGATTA**

##### **1 RULES**

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing 2009-2012*, the current IRC Rules, the current PHRF Regulations as administered by the YRA of LIS and Level or One-Design Class rules
- 1.2 Boats shall observe the Minimum Equipment Recommendations of YRA of LIS, Race Category C.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Part 5, Section B is changed to provide for arbitration of protests of Part 2 rules.

##### **2 ENTRIES**

- 2.1 Eligible boats may enter by registering on line at Yacht Scoring: [www.yachtscoring.com](http://www.yachtscoring.com) or on approved entry forms received by the Larchmont Yacht Club front desk not later than 1700, Wednesday, July 11, 2012
- 2.2 The Entry Fee is \$100.00.
- 2.3 There will be IRC, Level, One Design and PHRF divisions. At the discretion of the race committee separate divisions for Level and One-Design may be assigned. Divisions may be subdivided into classes.
- 2.3(a) For those classes not sailing Level or One Design, entries must be accompanied by a valid PHRF, IRC rating certificate. PHRF certificates from other areas will be adjusted to conform to the YRA of LIS. IRC certificates do not need to be endorsed.

##### **3 SAILING INSTRUCTIONS**

- 3.1 Sailing Instructions will be available at least one week before the regatta on the internet at: [www.larchmontyc.org](http://www.larchmontyc.org) and [www.yachtscoring.com](http://www.yachtscoring.com) or at the Larchmont Yacht Club front desk or the Hospitality Desk on the day of the event. Sailing instructions may also be available on the first day of racing prior to the first warning signal of the day from the committee boat.
- 3.2 Scratch Sheets will be available at the front desk after 1800 Friday, July 13, at the Hospitality Desk during the event and, and from the committee boat prior to the first warning signal of the day or on line at Regatta Manager.

##### **4 COURSES, RACING AREA AND RACES**

- 4.1 The racing area will be south of Milton Point.
- 4.2 The courses will be as described in the Sailing Instructions.
- 4.3 The warning for the first division will be at 1055 each day.

## **5 SCORING**

- 5.1 One completed race constitutes a series.
- 5.2 If fewer than five races are completed, a boat's series score will be the total of her race scores. If five or more races are completed a boat's series score will be the total of her race scores excluding her worst score subject to rule 90.3 (b).
- 5.3 For PHRF and CRF time allowances will be computed using Time on Distance.  
For IRC the boats rating allowance will be applied as a factor of the elapsed time.

## **6 PRIZES**

Series prizes for First, Second and Third places in each division will be awarded on Sunday, July 22 after racing on the front lawn of the Larchmont Yacht Club.

##### **1 RULES**

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing 2009-2012*, and the Woodenboat Regatta Series Rules Addendum A
- 1.2 Boats shall observe the Minimum Equipment Recommendations of YRA of LIS, Race Category C.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Part 5, Section B is changed to provide for arbitration of protests of Part 2 rules.

### NOTICE OF RACE ADDENDUM A

#### **1 GENERAL**

- 1.1 All yachts must have a current CRF Certificate.
- 1.2 Yachts may only have one valid CRF Certificate at a time, and may only submit one rating certificate per season. Other limitations on obtaining certificates may apply in the CRF rules.

#### **2 RULES CHANGES**

For the purposes of rules 10, 13, 14, 15 and 16, the definition of keep clear is changed to:

**Keep Clear:** One boat keeps clear of another when she is more than one of her hull lengths away from the other boat, the other can sail her course with no need to take avoiding action and, when the boats are overlapped on the same tack and the leeward boat can change course in both directions without immediately making contact with the windward boat.

#### **3 SCORING**

- 3.1 CRF Ratings converted to sec/mile will be used for scoring.
- 3.2 The seconds/mile between any two boats are calculated using the CRF seconds/mile table converted to a revised PHRF rating and entered in Yacht Scoring scoring program as a PHRF rating.
- 3.3 CRF non-spinnaker (base) ratings are to be used unless a separate spinnaker class is specified.
- 3.4 CRF Spinnaker ratings shall never be scored together with CRF non-spinnaker ratings. The ratings are not calibrated to accurately compare a spinnaker and non-spinnaker yacht.

#### **4 ELIGIBILITY**

Eligibility for each regatta is determined by the Notice of Race for that event. Yachts must meet those requirements in addition to these Classics Boat Rules.

#### **5 CLASS DESIGNATIONS**

##### **5.1 Classes**

CRF Vintage and CRF non-Vintage yachts shall not be scored together.

### 5.1.1 CRF Vintae

#### **Design, Construction and materials**

- Full keeled (or keel-centerboard), split-keel and rudder.
- Designed in or before 1970
- Steel / aluminum and wooden yachts
- Built utilizing original materials and methods as designed
- Minimum of 30' LOA, full decked (reasonable cockpit excepted), with accommodations.
- Fixed ballast
- Rigged with aluminum or wooden spars

#### **Sails (permitted)**

Woven fabric (Canvas, Nylon, Dacron as well as more contemporary woven fabrics such as Vectran and Hydranet). Note: What are prohibited are sails such as those utilizing advanced shaping technologies (3DL or similar), laminate or composite construction, or materials such as, but not limited to, Mylar, Kevlar, Spectra, Carbon Fiber, etc.

#### **Manual Power/Hydraulic Winches:**

For all yachts in the Classic Divisions whose LOA is greater than or equal to 70 feet, RRS 52 is deleted. RRS 52 shall still apply to Classic yachts with a LOA less than 70 feet. A Classic yacht with a LOA of less than 70 feet racing in contravention of RRS 52 will be designated to compete in the "CRF Non-Vintage" Division.

### 5.1.2 CRF non-Vintage

Yachts that evoke the pre-1970 design and/or spirit of Vintage yachts, but do not otherwise meet all of the above criteria for a Vintage yacht.

## 5.2 **Spinnaker Classes**

- a. For CRF rated yachts, separate spinnaker and non-spinnaker classes may be established as long as there is a minimum of four comparable yachts in each class.
- b. All boats shall race in non-spinnaker classes unless there is a minimum of four comparable yachts in both the spinnaker and non-spinnaker classes (minimum of 8 yachts).

## 6 **LIMITATIONS ON HEADSAILS & EQUIPMENT**

- 6.1 A whisker pole or spinnaker pole may be used to wing out a jib on the side opposite the main boom as long as no other sail, including a staysail, is set in the fore-triangle. Whisker or spinnaker poles shall not exceed 110% of the yacht's J-measurement.
- 6.2 Poles must be fixed at the mast while in use in accordance with RRS 50.2.
- 6.3 Spinnakers and Headsails are defined in accordance with RRS 50.4

#### **6.4 Non-Spinnaker Classes Sail Limitations:**

- a. Only one jib shall be carried in the fore-triangle at one time: i.e., drop one sail before setting another. This changes RRS 50.1.
- b. Bona fide double headsail rigs (*defined as being properly rigged, including permanent fixed points on deck and on the mast*) may carry a fore-triangle staysail that is hanked on to the inner forestay. All headsails must be tacked on the centerline of the boat.
- c. All sails set in the fore-triangle must be hanked on for the full length of the stay (except fixed-stay roller furling sails). Flying a headsail on its tack and head only, or on an internal wire luff, is not permitted.
- d. Mizzen staysails are permitted.
- e. All yachts shall be limited to sail area as defined in their CRF certificate. This includes a 150% max LP for headsails unless otherwise rated, in which case a yacht may fly a headsail up to their max rated LP on their certificate.

#### **6.5 Spinnaker Classes**

- a. Spinnaker classes are exempt from the above non-spinnaker sail limitations, but must comply with sail material and all other listed rules and eligibility requirements.
