NOTICE OF RACE

1 – Rules

- .1 – The Regatta will be governed by the rules as defined in *The Racing Rules of Sailing (RRS)*.
- .2 – The Regatta will be conducted and scored using PHRF Time on Time handicap ratings assigned by LMPHRF. Boats not having a current LMPHRF Certificate will be assigned a rating.

2 – Eligibility and Entry

- 2.1 – The regatta is open to all legally registered or documented sailboats that meet the equipment requirements of the State of Michigan and the U.S. Coast Guard.
- 2.2 – Eligible boats may enter by completing the entry form and sending it, together with the required fee, to: GTYC, Attn: Race Committee; PO Box 131; Traverse City MI 49685. Entry forms will be available with this document, at GTYC, or at http://gtyc.org/hound_dog.
- 2.3 – Entry fee is \$60 for those with US Sailing memberships and \$70 for those without for Spinnaker & Jib and Main.
- 2.4 – Entrants will be divided into two fleets; Spinnaker (SPNKR), Jib and Main (JAM).. Additional fleets may be added at the discretion of the Regatta Chair.

3 – Sailing Instructions – will be available at registration.

4 – Changes to RRS – RRS 35, Time Limit, and Appendix A, Scoring, will be changed as below.

NOTICE OF RACE

Amendments to Notice of Race:

Section 2.4

Originally read: Entrants will be divided into two fleets; Spinnaker (SPNKR), Jib and Main (JAM).. Additional fleets may be added at the discretion of the Regatta Chair.

Amend to Read: Entrants will be divided into three fleets; *Spinnaker A* (PHRF handicaps 99 and below), *Spinnaker B* (PHRF handicaps 100 and above), and *Jib and Main* (All PHRF Ratings)

Section 5

Amend to read: The first warning Saturday for the Spinnaker A start will sound at 1030 hrs. The combined start for Spinnaker B and JAM divisions will follow.

Amend to read: The first warning Sunday for the Spinnaker A start will sound at 1030 hrs. The combined start for Spinnaker B and JAM divisions will follow. No warning signal past 1400 hrs.

GRAND TRAVERSE YACHT CLUB WAIVER OF LIABILITY AND RELEASE FOR THE 2013 GTYC INVITATIONAL REGATTA

1. I have read the Sailing Instructions for the 2013 Grand Traverse Yacht Club Invitational Regatta and the Notice of Race instructions for each race I will enter the yacht named in this Registration Form, and the Release Agreement herein and agree that in signing this form I am bound thereby.
2. I understand that this racing event will be governed by the Racing Rules of Sailing, 2013-2016 and U.S. Sailing recommendations for offshore sailing. All races will use Category 4 regulations unless otherwise indicated in the Notice of Race. I agree to be bound by The Racing Rules of Sailing and all other rules that govern this event and to provision my boat in accordance with the safety regulations as specified for the event.
3. My crew and I recognize that sailing is an activity that has an inherent risk of damage and injury. We have read RRS 4, Decision to Race and hereby acknowledge and agree that we are participating in this racing event entirely at our own risk.
4. I acknowledge and agree that the Grand Traverse Yacht Club, its Board of Directors, Flag Officers, employees, Race Committee, committee boat participants, Protest Committee, race sponsors, members and agents involved in the organization, supervision and conduct of this racing event will not be responsible for damage to any boat or other property or the injury to any person participating in this racing event, including death, sustained as a result of participation in this racing event or sustained in conjunction with or prior to, during, or after the racing event.
5. In consideration for the opportunity to participate in this racing event, I hereby waive for myself and my heirs, legal representative, successors and assigns, any and all claims which I, and any of them, may have against the Grand Traverse Yacht Club, its Board of Directors, Flag Officers, employees, Race Committee, committee boat participants, any Protest Committee, any race sponsors race or other race organizers with respect to personal injury or property damage suffered by myself or my crew as a result of our participation in the racing event and hereby release the race organizers from any liability for such injury or damage to the fullest extent permitted by law.
6. This waiver is not intended to preclude claims by any individual competitor against any other competitor arising out of any alleged negligent conduct of said competitor.
7. I agree to the conditions of the racing event and state that my yacht will be outfitted, equipped, and handled in accordance with these conditions and that my yacht will comply with the applicable rules while racing. I specifically agree that it is my responsibility to see that this yacht is seaworthy in hull, rig, and gear and that she is competently manned.
8. I have taken all necessary steps to ensure that myself, my crew and the entered boat are adequately prepared for all possible contingencies, including appropriate safety equipment as may be required by law or that a prudent seaman would consider advisable.
9. I agree that I will maintain valid third party liability insurance coverage for my yacht during this racing event with a minimum coverage of \$300,000.00 per event or equivalent.
10. I understand this document has important legal consequences and have consulted such legal and other advisors as I deem appropriate before signing.
