

## **Addendum #1**

**AV8 and Open Windfoil have been invited to the Bacardi Invitational Regatta foiling circle with the following provisions:**

### **1. RULES**

1.1 The regatta will be governed by the Racing Rules of Sailing (RRS), including Appendix F for the AV8 Class and Appendix B & Appendix P applies to the Open Windfoil Class.

1.6 **ADD** – this doesn't apply to the competitors on the Foiling Circle

### **2. ADVERTISING**

2.2 AV8 and Open Windfoil Competitors may be required to carry advertising for event and class sponsors on their kiteboards, kites, lines, and on a lycra vest if supplied by the OA.

2.3 Every competitor in the AV8 and Open Windfoil Class is required to wear the official event lycra with their personal identification number whenever going afloat during the event.

### **3. ELIGIBILITY AND CLASSIFICATION**

3.1 The OA has extended an invitation to the Cabrinha AV8 class and Open Windfoil to be part of the Regatta.

3.5 – 3.8 Applies to the AV8 and Open Windfoil Class

3.5 Competitors under the age of 18 shall be required to complete the following:

- Parental/legal guardian consent - *for those under age of 18*
- Medical treatment permission - *for those under age of 18 or on their parents' medical insurance policy*

3.6 An entry is not considered complete until both the entry form, release waiver, medical waiver (if required), and entry fee have been received.

3.7 Helmets for Competitors in the Open Windfoil Class are required when sustaining windspeeds exceed 15 knots.

3.8 Personal buoyancy is mandatory for all competitors in the AV8 and Open Windfoil Class, above the waist, a jacket harness or vest with a minimum buoyancy of 4kg uninflated in fresh water. The buoyancy shall be tested with a ferrous metal weight of 4kg, which shall remain supported for a minimum of 5 minutes.

### **5. FEES**

Cabrinha AV8 class and Open Windfoil added. If received by February 1<sup>st</sup>, 2020 the entry fee is:

\$150 USD      (\$200 after February 1<sup>st</sup>, 2020)

The AV8 will include a \$50 Charter fee.

### **6. SCHEDULE**

**Add** AV8 and Open Windfoil to the schedule starting on March 5 1055 First Warning

### **10 PENALTY SYSTEM**

10.2 The AV8 and Open Windfoil Class sailing instructions may alternatively specify that competitors may choose between the turn penalty or a scoring penalty. This may change RRS F4 for the AV8 Class

10.3 The AV8 and Open Windfoil Class may use discretionary penalties and arbitration if outlined in the SI's.

## **17 INSURANCE**

17.2 The AV8 and Open Windfoil Class Competitors are required to carry third party insurance – minimum 1 million dollars (USD).

17.3 AV8 Competitors will be covered by Adventure Sports Inc. insurance upon signing their release and liability waiver on charter equipment provided when chartering an AV8.
